

CARBON CUTTING PRIZE DRAW TERMS AND CONDITIONS

1. The prize draw (the "Prize Draw") is open to people aged 13 and up. Only people who are UK residents are eligible to enter the prize draw because shipping internationally on this occasion would be against our environmental values.
2. People who comment their carbon cutting tips on the Facebook post will be entered into the prize draw.
3. Employees of Practical Action or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.
4. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
5. By submitting your comment onto the post, you agree to be contacted if you have won the prize draw. You will only be contacted by Practical Action if you have won the Prize Draw via direct messenger on Facebook.
6. To enter the Prize Draw you must comment on the Carbon Cutting post, your best tip or knowledge on how to cut down on carbon. No purchase is necessary. If you have any questions about how to enter or in connection with the Prize Draw, please contact us on Facebook via direct message.
7. Only one entry per person.
8. The closing date of the Prize Draw is 23:59 on 18th August 2019. Entries received outside this time period will not be considered.
9. One winner will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will take place on 19th August 2019.
10. The winner will receive a branded Practical Action water bottle and hessian bag.
11. Practical Action accepts no responsibility for any costs associated with the prize and not specifically included in the prize.
12. The winner will be notified via direct message on Facebook, on or after the 19th August 2019. If a winner does not respond to Practical Action within 3 days of being notified by Practical Action, then the winner's prize will be forfeited and Practical Action shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to the notification of their win within 3 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and Practical Action shall be entitled to select another winner.
13. Details of how to claim the prize will be provided to the winner.
14. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.
15. Practical Action retains the right to substitute the prize with another prize of similar value in the event the original prize offered is not available.
16. The winner may be required to take part in promotional activity related to the Prize Draw and the winner shall participate in such activity on Practical Action's reasonable request. The winner consents to the use by Practical

Action, after the closing date of the Prize Draw for an unlimited time, of the winner's voice, image, photograph and name for publicity purposes (in any medium, including still photographs and films, and on the internet) and in advertising, marketing or promotional material without additional compensation or prior notice.

Practical Action shall use and take care of any personal information you supply to it as described in its privacy policy, a copy of which can be found on Practical Action's website, and in accordance with data protection legislation. By entering the Prize Draw, you agree to the collection, retention and usage of your personal information in order to process and contact you about your Prize Draw entry. Your details will not be shared with any third party.
18. The Prize Draw will be governed by English law and entrants to the Prize Draw submit to the exclusive jurisdiction of the English courts.
